### **DECISION**

Marshal of the Zachodniopomorskie Province, acting on the basis of the Art. 9a clause 1 of the Act of October 13, 1995 Hunting Law (Journal of Laws of 2020, item 67, as amended), acting upon request from State Water Management Polish Waters The Regional Water Management Board in Szczecin, dated 2.04.2020, ref.: POPDOW-ZPT.070.5.2020 to grant a permit for waving the prohibition on disturbing wild game, taking into account the opinion of the Polish Hunting Association, District Board in Szczecin of May 4, 2020., ref. No. 208/04/2020

#### grants permit

- to State Water Management Polish Waters The Regional Water Management Board in Szczecin, ul.
   Tama Pomorzańska 13A, 70-030 Szczecin, to derogate the prohibition on disturbing wild game of the species: Eurasian teal (*Anas crecca*), tufted duck (*Aythya fuligula*), greylag goose (*Anser anser*), greater white-fronted goose (*Anser albifrons*), taiga bean goose (*Anser fabalis*), common pochard (*Ayntha farina*), common wood pigeon (*Columba palumbus*), mallard (*Anas platyrhynchos*), eurasian coot (*Fulica atra*).
- 2. The permit applies to disturbance of the abovementioned species during the completion of the project titled: "Modernization works on boundary sections of Odra River, Stage I to provide Good Condition for Ice—breaking." The disturbance will be taking place on the plots No.: 602/1, 602/3, 605, 202, 564, 203/9 and 546 surveying district 1 Mieszkowice, 202, 199/8, 200, 86/7 surveying district 2 Mieszkowice, 277, 228, 200, 286/4, 286/5, 190, 280/5, 281/3, 281/2, 281/1, 280/1, 279/7. 278/3, 91/3 and 247 surveying district 15 Cedynia, 340, 338, 688, 494, 497 and 687 surveying district 14 Cedynia, 298, 248, 205/2, 206/2 and 207 surveying district 13 Cedynia, 1, 252, 250/1, 241/4, 241/5, 174/1, 239/25, 239/20, 239/8, 167/7, 160/10, 160/13, 160/14, 239/4 and 239/5 surveying district 9 Cedynia.
- The entity authorized to perform the disturbing activities is:
   State Water Management Polish Waters The Regional Water Management Board in Szczecin, ul.
   Tama Pomorzańska 13A, 70 030 Szczecin.
- 4. This permit remains valid until February 28, 2023.
- 5. Immediately prior to proceeding with any activities, the species of eurasian teal (*Anas crecca*), tufted duck (*Aythya fuligula*), greylag goose (*Anser anser*), greater white-fronted goose (*Anser albifrons*), taiga bean goose (*Anser fabalis*), common pochard (*Ayntha ferina*), common wood pigeon (*Columba palumbus*), mallard (*Anas platyrhynchos*), eurasian coot (*Fulica atra*). If eggs or chicks are found in the nests, any disturbing activities should be put on hold until such time, when the chicks are able to

leave the nests on their own.

- 6. Implementation of the granted permit will be monitored in the field by employees of the Agriculture and Fisheries Department of the Marshal's Office of the Zachodniopomorskie Province, on the basis of the provisions of the Art. 9a clause 4 and Art. 44 clauses 6-12 of the Hunting Law of October 13, 1995.
- 7. Information on the implementation of the permit should be submitted to the Marshal of the Zachodniopomorskie Province by 31 March after the end of each calendar year throughout the validity of this permit.

#### **Explanatory statement**

State Water Management Polish Waters, Regional Water Management Board in Szczecin submitted a request to the Marshal of the Zachodniopomorskie Province in the application dated 2.04.2020, ref.: POPDOW-ZPT.070.5.2020 to derogate the prohibition on disturbing wild game of the species: eurasian teal (*Anas crecca*), tufted duck (*Aythya fuligula*), greylag goose (*Anser anser*), greater white-fronted goose (*Anser albifrons*), taiga bean goose (*Anser fabalis*), common pochard (*Ayntha ferina*), common wood pigeon (*Columba palumbus*), mallard (*Anas platyrhynchos*), eurasian coot (*Fulica atra*).

In accordance with the Art. 9a clause 1 of the Act of October 13, 1995 Hunting Law, Marshal of a Province may derogate the prohibition on disturbing wild game. The permit may be granted in the absence of alternative solutions and if it is not detrimental to the conservation of wild game populations.

The request submitted by the State Water Management Polish Waters, Regional Water Management Board in Szczecin for the permit granted by the Marshal of the Province to derogate the prohibition on disturbing wild game concerns eurasian teal (*Anas crecca*), tufted duck (*Aythya fuligula*), greylag goose (*Anser anser*), greater white-fronted goose (*Anser albifrons*), taiga bean goose (*Anser fabalis*), common pochard (*Ayntha ferina*), common wood pigeon (*Columba palumbus*), mallard (*Anas platyrhynchos*), eurasian coot (*Fulica atra*), and the planned disturbing activities are not detrimental to conservation of these birds' populations.

The Polish Hunting Association, in the letter dated May 4, 2020, Ref. No. 208/04/2020 raised no objections to the aforementioned application.

Considering the above, it was adjudicated as in the decision.

## Instruction

An appeal may be lodged against this decision to the Local Government Appeal Board in Szczecin, through the Marshal of the Zachodniopomorskie Province, within 14 days from the date the decision has been received.

During the time limit for lodging an appeal, a party may waive its right to lodge an appeal against a public administration authority which issued the decision, and if it does so, the decision shall become final and legally binding on the day of delivery of such statement to the authority, by the last party involved.
