NOTIFICATION

Pursuant to Art. 122c, § 1 of the Administrative Procedure Code of 14 June 1960 (Journal of Laws 2020, Item 256 as amended) and subject to Art. 118, Item 6, Point 1 of the Environmental Protection Act of 16 April 2004 (Journal of Laws 2020, Item 55), having considered the application of 23 April 2020 (Ref. No.: POPDOW-5.3-ZPT.060.1.2020) by Mr. Jerzy Siwicki, proxy of the Investor, i.e. Państwowe Gospodarstwo Wodne Wody Polskie, related to notification of performing activities pursuant to Art. 118, Item 1, Point 4 of the Environmental Protection Act, and consisting in modernization of the area between Osinów - Łubnica embankments for flood protection of Piasek,

I hereby express no objection to the application.

Statement of reasons

On 24 April 2020 Mr. Jerzy Siwicki, Sweco Consulting Sp. z o.o., ul. Łyskowskiego 16, 71-641 Szczecin, notified local RDEP of the intent to perform activities consisting in modernization of the area between Osinów - Łubnica embankments for flood protection of Piasek. The activities will be carried out in Cedynia and Chojna municipalities, at the following registered lots: 1/16, 144/1, 144/2, 145, 153, 343/1, 343/2, 343/3, 342, 344, 345, 346, 347, 410, 411, 412, 413, 414, 417, 418, 419, 420, 426, 427/1, 427/2, 485/1, 483, 484, 669, 671, 672, 675, 676, 677, 678, 679, 680 (Piasek 0002 district), 12/1 (Raduń 0001 district). The lots are covered by the following nature protection programs: Nature 2000, Lower Odra Valley PLB320003, Nature 2000, Lower Odra PLH320037, Cedynia Landscape Park.

The Regional Director for Environmental Protection in Szczecin, having considered the application, has no objection to conducting the activities pursuant to Art. 118 of the Environmental Protection Act of 16 April 2004 (Journal of Laws 2020, Item 55).

According to Art. 118, Item 6, Point 2 of the Environmental Protection Act, the activities specified in the notification can be started not later than 2 years after their commencement date stated in the notification.

At the same time I would like to state that if the investment project infringes bans related to protection of species, a derogation permit should be obtained according to Art. 56 of the Environmental Protection Act of 16 April 2004.

Given the above, it was ruled as stated.
