Notice to Skippers No. 15/2022

Pursuant to Art. 43 point 6 of the Act of 21 December 2000 on inland navigation (consolidated text: Dz. U. /Journal of Laws/ of 2020 1863), State Water Holding "Polish Waters" Regional Water Management Board in Szczecin in consultation with Inland Navigation Office in Szczecin hereby informs that due to the need for hydrophobization of the bridge deck slab of the load-carrying structure of the newly constructed bridge along ul. Krygiera at 734.6 km of the Regalica river, **from 6 June 2022 to 13 June 2022 there will be some difficulties in the shipping traffic due to the need for change in traffic organisation.**

Shipping traffic organisation will be carried out according to the following schedule and variant of the bridge crossing:

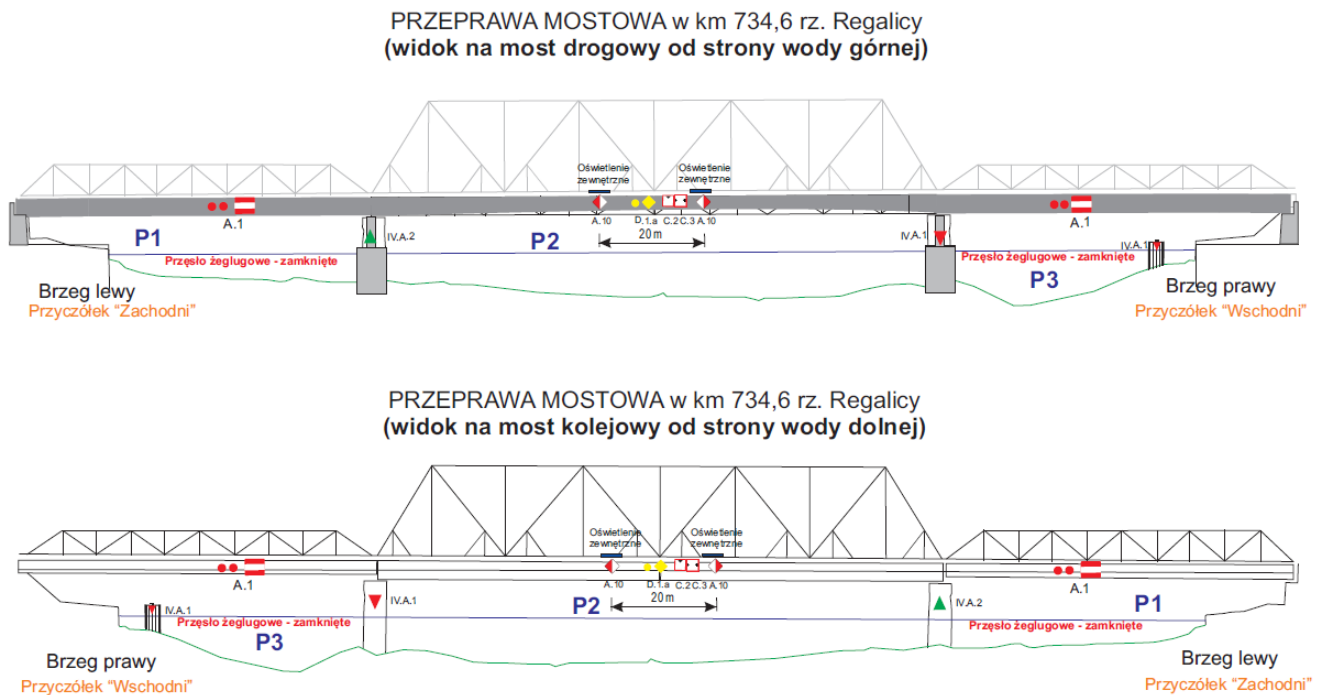


Fig.1 Shipping traffic under the middle bridge span

- 6 June 2022 – works carried out in the area of "Przyczółek Zachodni" [Western Abutment], shipping traffic under the middle bridge span as at present (Fig. 1).
- 7 June 2022 – works carried out in the area of "Przyczółek Zachodni" [Western Abutment] and "Przyczółek Wschodni" [East Abutment], shipping traffic under the middle bridge span as at present.

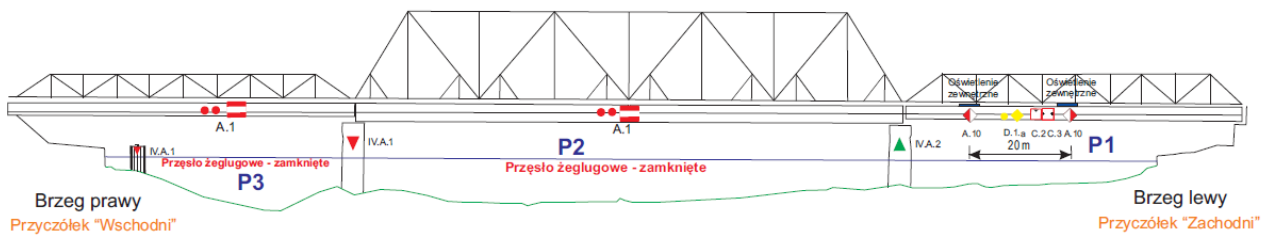


Fig.2 Shipping traffic under the western bridge span

- 8 June 2022 – change in shipping traffic from the middle bridge span to the left-bank span of the bridge (Fig. 2)

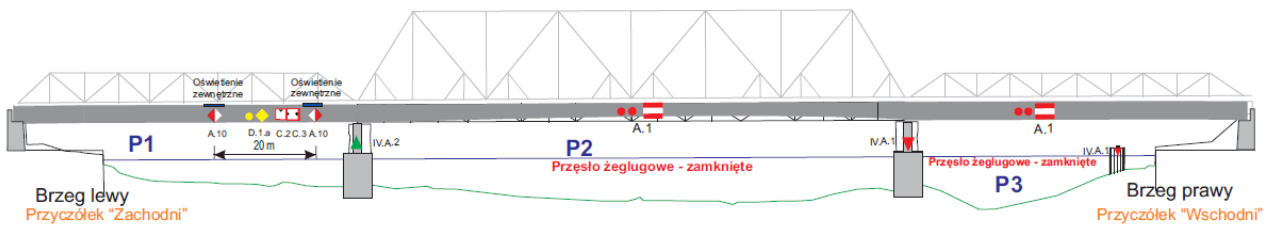

- 9 June 2022 – works related to hydrophobization of the middle bridge span together with bridge piles.
- 13 June 2022 – restoration of shipping traffic under the middle bridge span (Fig. 1)

(widok na most kolejowy od strony wody dolnej)
