Notice to Skippers No. 12/2022

Pursuant to Art. 14 sec. 1, point 4 of the Act of 20 July 2017 – Water Law (Dz. U. /Journal of Laws/ of 2021, item 2233, 2368, of 2022, item 88, 258, 855) and Art. 43 sec. 6 of the Act of 21 December 2000 on Inland Navigation (Dz. U. /Journal of Laws/ of 2020, item 1863, of 2021, item 2490), the Regional Water Management Board in Szczecin, in agreement with the Inspectorate of Inland Navigation in Szczecin and the Oder-Havel Waterway and Shipping Office in Eberswalde, informs that on **29 April 2022**, signs displayed on the border section of

the Oder River:

- starting from km 542.4 (mouth of the Lusatian Neisse) up to km 704.1 (Weir in Widuchowa),

the West Oder:

- starting from km 0.0 (Weir in Widuchowa) to km 17.1 (state border),

and within Poland, the downstream sections of the rivers:

East Oder and Regalica:

- starting from km 704.1 (Weir in Widuchowa) to km 741.6 (mouth of the Regalica to Dąbie Lake),

West Oder:

- starting from km 17.1 (state border) to km 36.6 (border with internal sea waters),

and

Dąbie Lake and other inland waterways of the Szczecin Water Junction,

meet the requirements set in Art. 7 of the Order No. 1/2020 of the Director of the Office of Inland Navigation in Szczecin, of 10 March 2022, on navigation on boundary waters of the Oder, West Oder and Lusatian Neisse (Official Journal of the West Pomeranian Voivodeship, Szczecin, 11 March 2022; Official Journal of the Lubuskie Voivodeship, Gorzów Wielkopolski, 10 March 2022) and requirements specified in Art. 25 of the Order No. 1/2020 of the Director of the Office of Inland Navigation in Szczecin, of 17 February 2020, on detailed conditions of navigation and berthing safety (Official Journal of the West Pomeranian Voivodeship, Szczecin of 18 February 2020, item 906), which regulate the rules of night navigation.

In view of the above, we inform you that the signs displayed over the above-mentioned sections meet the requirements governing the rules of night navigation.

NOTE:

The exception is the bridge profile at km 580.0 (A-2 motorway bridge - Świecko), where works are currently in progress to restore night-time navigation signs.

The "Polish Waters" National Water Holding, Regional Water Management Board in Szczecin will issue a notice informing about the opening of the above waterway section for navigation.
